- I Timothy Ives born around 1610 came from England to America around 1638. John Marshall got 100 acres for bringing Timothy and his wife Margaret in the eastern branch of the Elizabeth River in 1656 of Lower Norfolk County (Cavaliers and Pioneers p 332). Timothy received a land grant for 150 acres of land 15 June 1649, which means he was no longer an indentured servant of John Marshall. It was a gift from William Church (from Genealogy of the Ives Family by Arthur Coon Ives). Timothy sold 500 acres to Richard Church in 20 April 1668 (Cavalier and Pioneers p 40). Timothy Ives Jr. received 270 acres 15 Mar 1675 and 200 acres granted Richard Jones, Sr. 28 April 1665 and assigned to Timothy Ives, Sr. 15 Feb 1671 who assigned it to his son Timothy, Jr. Timothy, Sr. had three sons
